

Masercati Kitten / Cat Contract

THIS AGREEMENT made the _____ day of _____ 20_____

BETWEEN _____ (hereinafter called 'the Breeder')

of the one part and _____ (hereinafter called 'the Purchaser')

of the other part WHEREBY IT IS AGREED that for a consideration of £

receipt of which the Breeder hereby acknowledges the Breeder agrees to sell and the Purchaser agrees to purchase the kitten described herein under the name of

Our cats and kittens are guaranteed to be of sound health, at the time of sale, and for a period of 72 hours. If the cat/kitten is found to be ill, during that time, it must be reported immediately, with confirmation from a certified veterinarian, for reimbursement of veterinary bills. If he/she is found to be medically deficient, with an untreatable or life-threatening genetic condition, within a year, it must be reported immediately. A replacement cat/kitten of equal value will be provided within 6 months of the return/demise of the ill cat/kitten. This will be done ONLY with a certified veterinarian's certificate of diagnosis and/or cause of death.

The cat/kitten cannot be returned after the 72 hours, and/or if he/she has been exposed to other animals that have not been currently tested for FeLV and FIV.

It is the responsibility of the purchaser to provide immediate medical care if the cat/kitten shows signs of illness or distress. Failure to do so will render any guarantee null and void.

Cats/kittens that are sold as breeders will come with full breeding rights and no restrictions on him/her or his/her offspring that is not included in an amendment to this contract, signed by both parties at the time of sale. The purchaser will be provided with all registration papers and pedigree information at the conclusion of the sale as dictated by this contract and any amendment that is included.

Cats/kittens sold as pets, will be neutered by a Veterinary Surgeon/Practitioner, before attaining the age of twelve months. The purchaser agrees to prevent this cat/kitten from breeding without permission of Masercati Cattery. Not under any circumstances whatsoever to use the kitten for breeding or allow the kitten to breed with any other cat of the same or a different species, neither will the Purchaser allow any such use to be made of the kitten by any other party.

The purchaser will produce to the Breeder a Certificate from the Veterinary Surgeon/Practice stating that this has been carried out. The transfer/registration and pedigree certificate will then be issued to the Purchaser.

If for any reason it becomes necessary for the Purchaser to transfer the kitten to a third party the Purchaser undertakes to obtain from the third party a covenant in similar terms to those contained herein.

In the event of these covenants being breached the Breeder shall have the right to repossess legally the kitten and to be reimbursed by the Purchaser the reasonable cost of such repossession and the keeping of such kitten for a period of up to two months after repossession. Such costs to include Veterinary examination and fees.

There is no guarantee of Show Quality, unless the cat/kitten being sold has been shown and has placed in at least one final in an official cat show.

Under no circumstances will the purchased cat/kitten be placed in a shelter, or abandoned and should be returned to the Breeder for re-homing.

It is agreed that this cat/kitten will be maintained as an indoor-only pet, and not be allowed to roam outside. The purchaser agrees to provide a safe and healthy environment for this cat/kitten.
